Blackline Safety – 2 options : \$1,278 per device first year – this is price of devices and 1 year service. After purchase of devices- the annual fee will be \$684 for the self-monitoring services. Option 2: 1,554. – same device but they monitor the calls for us. Safety council is asking for **option 1: \$1,278 per device and one time training fee of \$300. Totals \$7,968**
